



Enrollment Process for Independent Beachbody® Coaches Seeking Military Waiver

Beachbody is proud to offer the military waiver to qualified Coaches. Beachbody offers this waiver of our standard enrollment fee (\$39.95 plus tax) and the monthly Business Service Fee (\$15.95 plus tax) to U.S military service members enrolled as Independent Beachbody Coaches. Those eligible include active duty service members, spouses of active duty service members not already enrolled as a Coach, military reservists from any branch of service, spouses of military reservists from any branch of service not already enrolled as a Coach, honorably discharged military veterans (including those discharged early as a result of injuries sustained in the course of service), spouses of honorably discharged military veterans and spouses of military service members who were lost or killed in action.

If you have already enrolled as an Independent Beachbody Coach and not yet taking advantage of the military waiver, please submit proof of your qualification to [Beachbody Support](#). Acceptable documents include (a) a copy of your active duty orders, (b) a copy of a recent LES which confirms your current assignment; or if you are a veteran of the military, (c) a copy of your DD214 or NGB22. Please note we **will not** accept a copy of your military ID as proof of your eligibility. Once your documents are received and approved, your future business service fees will be waived. If you submit paperwork within 30 days of your enrollment as a Beachbody Coach, your standard enrollment fee (\$39.95 plus tax) will also be refunded. Please note if you purchased a challenge pack at the time of your enrollment, the \$39.95 fee has already been waived, and no further refund would apply.

For individuals who have not yet enrolled as a Coach, please complete your online enrollment as a Coach, and once your account has been created, please submit your military paperwork to [Beachbody Support](#) following the guidance in the paragraph immediately above. For your convenience, page two of this document can be used as a cover sheet for your submission.

If you submit incomplete paperwork for the military waiver, our Service Team will reach out to you to request additional information. If you have questions about your own eligibility, please review our guidelines as stated in the Team Beachbody Coach Policies & Procedures, a copy of which is available in your online office. Military Waiver Request

Once you have enrolled as an Independent Beachbody Coach and wish to apply for our military waiver, please provide confirmation of your status, as noted in the attached instruction sheet.

Please note that under no circumstance will we accept a copy of your military ID in order to qualify for this waiver. Your documents may be submitted to [Beachbody Support](#).

Once paperwork has been reviewed, you will receive further confirmation of the waiver acceptance via email. If additional paperwork or information is required in order to complete this process, our Service Team will contact you directly.
